

2010 Contest Rules

1. Contest open to all ages
2. Photographer must be an amateur, ie. has not been employed professionally as a photographer in any manner.
3. Photo must have been taken in Vinton County after January 1, 2006.
4. Photographer can enter up to four photos per category but each photo can only be entered in one category.
5. The photo entered must be the work of the person entering the photo.
6. Photo must be submitted electronically. Submissions can be made at www.vintoncountytravel.com, can be emailed to info@vintoncounty.com or be submitted on a compact disc. Entries can be submitted on disc in person or by mail to the CVB at 104 W. Main St. P.O. Box 307 McArthur, Ohio 45651.
7. Entries must be accompanied by an entry form OR by the following information: the entrant's name, address and phone number; Contest Category; and the title of the photo and a brief description of the photo.
8. The file name must be formatted as follows: Photo Title by Photographer's Name (ex. A Sunny Day by Jane Doe)
9. Photographers with winning entries will be notified by mail within 30 days of the official judging which occurs within 15 days of the final entry date.
11. All photos submitted as entries to the contest become the property of the Vinton County CVB. Entrants forfeit ownership and all rights thereof to the Vinton County CVB.
12. Photos that contain the distinguishable faces of people must be accompanied by a photo release signed by each person. Contact the CVB Office at 740-596-5033 or email info@vintoncounty.com to obtain a copy of this form.
13. There can be no Photoshopping or other digital manipulation of the photo. This does not apply to cropping an image.
14. Entries due to the CVB by 4:00 p.m. on Friday, April 20, 2012

Composition Lighting

Clarity Subject Matter

How well the photo reflects Vinton County Impact

How well the matting compliments the picture Degree of Difficulty

Points will be deducted for failure to follow contest criteria.

Grand Prize

A grand prize of \$250 minimum value will be awarded to the top overall winning entry.
